PROCEEDINGS OF THE STATE LEVEL TECHNICAL COMMITTEE (SLTC)
MEETING HELD ON 08.03.2023 at TSCAB, H.O., HYDERABAD TO FIX
SCALES OF FINANCE FOR THE YEAR 2023-24.

The State Level Technical Committee (SLTC) meeting of Telangana State was convened on 08.03.2023 at TSCAB, Head office. The Managing Director, TSCAB (Convenor, SLTC) welcomed Sri M Raghunandhan Rao, IAS, Agriculture Production Commissioner (APC)/ Secretary to Govt. of Telangana (Chairman, SLTC), Officials of SLBC, NABARD, various Department heads, Universities, Bankers and other members of the Committee and requested to introduce themselves.

The Convenor briefly explained about the importance of adequate and timely credit requirements for the farming activities and stated that the key to these credit requirements is the Scales of Finance (SoF) fixed for each crop and which forms the base for determining/arriving the limit to KCC. In this context, the Convenor gave a detailed snapshot on the role of SLTC in fixing Scales of Finance (SoF).

Further, the Convenor explained in detail about the NABARD's revised guiding principles viz Re-constitution of DLTC & SLTC, fixing of SoF by DLTC & SLTC, timelines, notification etc., communicated through their circular dated 15.04.2020 and informed that as per NABARD revised

guidelines, Govt. of Telangana has also issued a G.O. Rt.No.119 dated 02.03.2021 on re-constitution of SLTC.

The Convenor informed that the proposals forwarded by DLTCs were consolidated and the information obtained from various Govt. departments was placed before the Committee for detailed discussion and requested Committee members to review the proposals and fix realistic SoF for each crop by considering various technical inputs, different agro climatic zones, irrigated/Unirrigated, methods of cultivation, nuances in the cropping pattern etc., and further advised the delegates to actively participate and offer their valuable suggestions to fix and adopt the Scales of Finance for 2023-24.

During the discussions in the SLTC meeting, the Chairman Sri M Raghunandhan Rao, IAS, APC/Secretary to Govt. of Telangana, has advised to work out the Gross Value of Production (GVP) for some of the major crops having Minimum Support Price (MSP). The members of SLTC had detailed discussions on the cost of cultivation, Gross Value of Production (GVP) basing on Geographical conditions of each district pertaining to all major crops and approved suggestive range of Scales of finance, by considering the local factors.

The officials from Departments of Agriculture, Horticulture, Animal Husbandry & Fisheries, Agriculture University, ICAR, Veterinary University, Horticulture University, NABARD, SLBC, Telangana Grameena

Bank, SBI, Union Bank of India, Punjab National Bank, Bank of Baroda, Canara Bank and HDFC Bank have extended their valuable suggestions and played an important role in fixing of Scales of Finance for various crops and Working Capital requirement for Animal Husbandry and Fisheries activities.

The Committee resolved not to fix SoF for Jatropha crop as there is no market for the crop and approved to fix SoF for some of the new crops such as Tasar Culture, Tomato(Mulching) etc., for the Financial Year 2023-24. Further, as advised by MoA&FW, GoI, SoF was fixed for Lac Framing, Honey Bee Rearing and Silkworm Rearing for the Financial Year 2023-24.

The Deputy Director of Horticulture, Sri B. Babu, has played an important role in fixing the Scales of Finance in respect of all Horticultural crops by sharing his ground level experiences with the members of the Committee. Further, Dr.T.Suresh Reddy, Principal Scientist from Horticulture University has explained in detail of various activities involved in cultivation of Horticultural crops which made helpful in fixation of realistic SoF.

The representative from Animal Husbandry Department Dr. Sachin Desh Pande, (AD Plg) has expressed his views by giving detailed explanation of Working Capital components for fixation of Scales of Finance under Animal Husbandry. Further, Dr.T.Srinivasa Mohan, DGM,

NABARD (Retd) has also given his recommendations to fix SoF for Animal Husbandry and Fisheries activities.

The Official from Fisheries Dept has explained about the Working Capital requirements for various fisheries activities and Dr B. Ekambaram, Director of Research from Veterinary University has also given valuable suggestions in fixing SoF for Animal Husbandry and Fisheries activities.

After elaborate discussions, the Committee resolved to fix Uniform Scales of finance across the Telangana State and advised the respective DLTCs to follow the Scales of Finance fixed by the SLTC for the Financial Year 2023-24.

The meeting was concluded with Vote of Thanks by Chief General Manager, TSCAB.
